 - Includes: Fitness center, swimming pool, and social access.

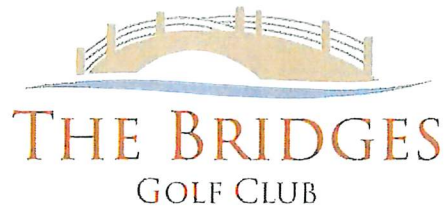

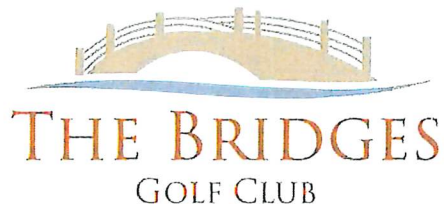
